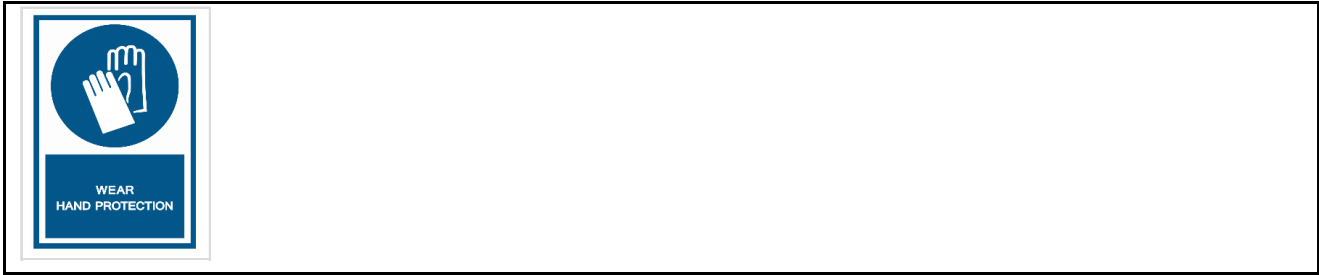

Ensure floor completely dry and clean , strip any previous polish or wax with Wax Stripper / Dual Step , Apply Floor Wax in a thin coat with a mop or applicator. Allow it a 15 - 20 minutes time to harden and proceed with second coat and repeat process till desired hardness. Buff to maintain a good shine or to remove any stains.
